SHIPPED SEMEN STALLION SERVICE CONTRACT

This certifies that _____ herein referred to as the Mare Owner, has engaged one breeding to _____ for the _____ breeding season at _____ for the following mare:

Amity Acres, owner of the above stallion, will herein be referred to as the Breeder. This service is subject to the following:

1. A **non-refundable** booking fee of \$ _____ is payable with this contract. The balance of \$ _____ and service charge for the first shipment are due before any semen will be shipped. No contract will be approved until the fees are paid.
2. A copy of the registration papers (both sides) shall be sent to the Breeder with this contract.
3. Shipping days will be every Monday, Wednesday, and Friday beginning

February 1 and ending June 1 of the year of the contract.

4. The Breeder is to be notified no later than 7:00 A.M. Eastern Time on the
day of the shipment.
5. Shipped semen service charges will be as follows:
48 contiguous states - shipped FedEx Priority Overnight - \$250.00
Canada - shipped FedEx Priority Overnight - \$275.00
These charges **must** be paid prior to each shipment.
6. Live foal guarantee: Live foal means that the foal will stand and nurse. It is understood that if the mare proves barren, aborts her foal, or if the foal is stillborn, a return breeding will be guaranteed for the
following year only at the Breeder's facility, providing proper notification
is given. Proper notification is a written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare owner verifies that such an abortion or death did not result from any act or omission of the mare owner. Rhino Vaccinations must be administered as indicated by the individual drug manufacturer as the mare progresses through her pregnancy. Failure to do this will void the live foal guarantee.
7. Genetic disease: The Breeder shall be held harmless of any horse with genetic diseases (HYPP)(HH).
8. Third year rebreeds are subject to an additional booking fee plus any increases in the breeding fees. No live foal guarantee on third year rebreeds.
9. A breeders certificate will be issued to the Mare Owner after all expenses have been paid in full and upon notification of birth of the foal.
10. This contract is governed by the laws of the Commonwealth of Pennsylvania.
11. This is no Paint color guarantee.

12. This contract is not valid unless completed in full. When Mare Owner signs and returns the contract and booking fee to the Breeder, Breeder will notify Mare Owner within ten (10) days of approval. Upon notification it will become a binding contract on both parties, subject to the above terms and conditions.
